

NOTICE OF PRIVACY PRACTICES

THIS NOTICE DESCRIBES HOW MEDICAL INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION PURSUANT TO FEDERAL REGULATIONS. PLEASE REVIEW IT CAREFULLY.

At Chicago Surgical Specialists, we understand that information about you and your health is personal. We are committed to protecting your health care information. We create a record of the care and services you receive directly from our medical staff. We need this record to provide you with quality care and to comply with certain legal requirements. This Notice of Privacy Practices ("Notice") applies to all of the records of your care generated by Chicago Surgical Specialists.

This Notice will tell you about the ways in which Chicago Surgical Specialists may use and disclose your protected health information ("PHI"). This Notice also describes your rights and certain obligations Chicago Surgical Specialists has regarding the use and disclosure of PHI.

REGULATORY REQUIREMENTS. Chicago Surgical Specialists is required by law to maintain the privacy of your PHI, to provide individuals with notice of Chicago Surgical Specialists legal duties and privacy practices with respect to PHI, and to abide by the terms described in the Notice currently in effect.

RIGHTS. You have the following rights regarding your PHI:

Restrictions. You may request that Chicago Surgical Specialists restrict the use and disclosure of your PHI. To request restrictions, you must make your request in writing to our Privacy Officer using the applicable Chicago Surgical Specialists form. In your request, you must tell us (1) what information you want to limit; (2) whether you want to limit our use, disclosure or both; and (3) to whom you want the restrictions to apply, for example, disclosures to your spouse.

Alternative Communications. You have the right to request that communications of PHI to you from Chicago Surgical Specialists be made by particular means or at particular locations. For instance, you might request that communications be made at your work address, instead of your home address. Your requests must be made in writing using Chicago Surgical Specialists form and sent to the Privacy Officer. Chicago Surgical Specialists will accommodate your reasonable requests.

Inspect and Copy. Generally, you have the right to inspect and copy your PHI that Chicago Surgical Specialists maintains, provided that you make your request in writing to Chicago Surgical Specialists Privacy Officer. If you request copies of your PHI, we may impose a reasonable fee to cover copying and postage. If we deny access to your PHI, we will explain the basis for denial and your opportunity to have your request and the denial reviewed by a licensed health care professional (who was not involved in the initial denial decision) designated as a reviewing official. If Chicago Surgical Specialists does not maintain the PHI you request and if we know where that PHI is located, we will tell you how to redirect your request.

Amendment. If you believe that your PHI maintained by Chicago Surgical Specialists is incorrect or incomplete, you may ask us to correct your PHI. Your request must be made in writing, and it must explain why you are requesting an amendment to your PHI. We can deny your request if your request relates to PHI: (i) not created by Chicago Surgical Specialists; (ii) not part of the records Chicago Surgical Specialists maintains; (iii) not subject to being inspected by you; or (iv) that is accurate and complete. If your request is denied, we will provide you a written denial that explains the reason for the denial and your rights to: (i) file a statement disagreeing with the denial; (ii) if you do not file a statement of disagreement, submit a request that any future disclosures of the relevant PHI be made with a copy of your request and Chicago Surgical Specialists denial attached; and (iii) complain about the denial.

Accounting of Disclosures. You generally have the right to request and receive a list of the disclosures of your PHI we have made at any time

during the six (6) years prior to the date of your request (provided that such a list would not include disclosures made prior to April 14, 2003). The list will not include disclosures made at your request, with your authorization, and does not include certain uses and disclosures to which this Notice already applies, such as those: (i) for treatment, payment, and health care operations; (ii) made to you; (iii) for Chicago Surgical Specialists patient list;

(iv) for national security or intelligence purposes; or (v) to law enforcement officials. You should submit any such request to Chicago Surgical Specialists Privacy Officer. Chicago Surgical Specialists will provide the list to you at no charge, but if you make more than one request in a year you will be charged a fee of the costs of providing the list.

HOW WE MAY USE AND DISCLOSE MEDICAL INFORMATION ABOUT YOU. [ABBREVIATED] may use or disclose your PHI for the purposes described below **without obtaining written authorization from you.** In addition, Chicago Surgical Specialists and the members of its medical and allied health professional staff who participate in the organized health care arrangement described below may share your PHI with each other as necessary to carry out their treatment, payment and health care operations related to the organized health care arrangement. Chicago Surgical Specialists may also disclose your PHI to certain contractors or other business associates that provide service to Chicago Surgical Specialists; these "Business Associates" will be subject to HIPAA and are required to comply with the same restrictions and prohibitions that apply to Chicago Surgical Specialists.

For Treatment. Chicago Surgical Specialists may use and disclose PHI in the course of providing, coordinating, or managing your medical treatment, including the disclosure of PHI for treatment activities of another health care provider.

For Payment. Chicago Surgical Specialists may use and disclose PHI in order to bill and collect payment for the health care services provided to you. For example, Chicago Surgical Specialists may need to give PHI to your health plan in order to be reimbursed for the services provided to you. Chicago Surgical Specialists may also disclose PHI to its business associates, such as billing companies, claims processing companies, and others that assist in processing health claims. Chicago Surgical Specialists may also disclose PHI to other health care providers and health plans for the payment activities of such providers or health plans.

For Health Care Operations. Chicago Surgical Specialists may use and disclose PHI as part of its operations, including for quality assessment and improvement, such as evaluating the treatment and services you receive and the performance of staff and physicians in caring for you, patient surveys, provider training, underwriting activities, compliance and risk management activities, planning and development, credentialing and peer review activities, and health care fraud and abuse detection or compliance, and management and administration. Chicago Surgical Specialists may disclose PHI to doctors, nurses, technicians, students, attorneys, consultants, accountants, and others for

review and learning purposes, to help make sure Chicago Surgical Specialists is complying with all applicable laws, and to help Chicago Surgical Specialists continue to provide quality health care to its patients.

As Required by Law and Law Enforcement. Chicago Surgical Specialists may use or disclose PHI when required to do so by applicable laws and when ordered to do so in a judicial or administrative proceeding. Chicago Surgical Specialists may also use or disclose PHI upon a properly documented and limited request from law enforcement agencies.

For Public Health Activities and Public Health Risks. Chicago Surgical Specialists may disclose PHI to government officials in charge of collecting information about births and deaths, preventing and controlling disease, or to notify a person who may have been exposed to a communicable disease or may be at risk of contracting or spreading a disease or condition.

For Health Oversight Activities. Chicago Surgical Specialists may disclose PHI to the government for oversight activities authorized by law, such as audits, investigations, inspections, licensure or disciplinary actions, and other proceedings, actions or activities necessary for monitoring the health care system, government programs, and compliance with civil rights laws.

Coroners, Medical Examiners, and Funeral Directors. Chicago Surgical Specialists may disclose PHI to coroners, medical examiners, and funeral directors for the purpose of identifying a decedent, determining a cause of death, or otherwise as necessary to enable these parties to carry out their duties consistent with applicable law.

Research. Under certain circumstances, Chicago Surgical Specialists may use and disclose PHI for medical research purposes. For example, a research project may involve comparing the health and recovery of all patients who received one medication to those who received another, for the same condition.

To Avoid a Serious Threat to Health or Safety. Chicago Surgical Specialists may use and disclose PHI, to law enforcement personnel or other appropriate persons, to prevent or lessen a serious threat to the health or safety of a person or the public.

Specialized Government Functions. Chicago Surgical Specialists may use and disclose PHI of military personnel and veterans under certain circumstances. Chicago Surgical Specialists may also disclose PHI to authorized federal officials for intelligence, counter intelligence, and other national security activities, and for the provision of protective services to the President or other authorized persons or foreign heads of state or to conduct special investigations.

Disclosures to You or for HIPAA Compliance Investigations. Chicago Surgical Specialists may disclose your PHI to you or to your personal representative, and is required to do so in certain circumstances described below in connection with your rights of access to your PHI and to an accounting of certain disclosures of your PHI. Chicago Surgical Specialists must disclose your PHI to the Secretary of the United States Department of Health and Human Services (the "Secretary") when requested by the Secretary in order to investigate Chicago Surgical Specialists compliance with privacy regulations issued under the federal Health Insurance Portability and Accountability Act of 1996.

Patient List; Marketing. Unless you object, Chicago Surgical Specialists may use some of your PHI to maintain a list of patients it has served. This information may include your name, treatment facility, and the services Chicago Surgical Specialists provided to you. This patient list and the information on it may be used for marketing purposes.

Disclosures to Individuals Involved in Your Health Care or Payment for Your Health Care. Unless you object, Chicago Surgical Specialists may disclose your PHI to a family member, other relative, friend, or other person you identify as involved in your health care or payment for your health care.

OTHER USES AND DISCLOSURES. Other types of uses and disclosures of your PHI not described above will be made only with your written authorization; you have the right to revoke your authorization in writing. If you revoke your authorization, Chicago Surgical Specialists will no longer use or disclose PHI about you for the reasons covered in your written authorization. Please understand that Chicago Surgical Specialists is unable to recover any disclosures already made with your authorization, and that Chicago Surgical Specialists is required to retain records of the care provided to you.

RIGHT TO FILE A COMPLAINT. At Chicago Surgical Specialists we value the relationships we develop with our patients, our patients' privacy, and the trust our patients' have in us. As such, we make every effort to remedy any issues or concerns you may have. You may submit any complaint regarding your privacy rights to:
